#### **Cilji in kompetence:**

Da bi lahko razumeli kompleksno ekonomsко in poslovno okolje, je sposobnost kompetentne kvantifikacije in analize ekonomskih in poslovnih podatkov ključnega pomena. Regresijska analiza je eden najbolj celovitih pristopov za dosego tega cilja. Namen tega predmeta je nasloviti osnovne metodološke koncepte linearne regresijskega modela in nato na podlagi tega uvesti tri dodatne, bolj specializirane teme: univariatne časovne vrste, modele diskretne izbire ter analizo panelnih podatkov. Predmet je zelo praktično orientiran, saj so vse analizirane teme praktično predstavljene na številnih primerih.

#### **Objectives and competences:**

In order to understand the complicated economic and business environment it is vital to be able to competently quantify and analyze economic and business data. Regression analysis is one of the most comprehensive approaches to achieve this goal. The purpose of this course is thus to address the basic methodological concepts related to the linear regression model and then introduce, based on this, three additional, more specialized topics; univariate time series, discrete choice analysis and panel data analysis. The course is very much practically oriented; the analyzed topics are applied to data in various examples.

#### **Predvideni študijski rezultati:**

Ko bodo opravili predmet, naj bi bili študenti sposobni neodvisno zasnovati svoj raziskovalni problem in z dodatnim študijem metodoloških pristopov, ki jih bodo uporabili, izvesti aplikativno regresijsko analizo.

#### **Intended learning outcomes:**

After completing this course, the student should be able to set up independently his research problem and, with additional study of the methodological topics used in his analysis, perform the applied regression analysis.

#### **Metode poučevanja in učenja:**

Predmet je sestavljen iz predavanj in računalniških primerov. Metodološki pristopi, ki se jih študenti naučijo na predavanjih, so nato praktično prikazani na računalniških primerih.

#### **Learning and teaching methods:**

The course consists of lectures and computer exercises. Methodological approaches that are taught at any given lecture are then demonstrated at the subsequent computer session.
